**Race Description:** 5km OC-6 races in beautiful English Bay. OC-6 canoes will be provided by FCRCC. Races will run in heats of five canoes at a time. Men and Women heats will be in the morning. Mixed heats will be in the early afternoon. You can race twice.

**Race Prizes:** Teams with top three times of the day in each official category win prizes. Many draw prizes will also be given out during the award ceremonies.

**Race Location:** FCRCC Outrigger Compound, Burrard Marina, Vanier Park. As you travel north along Whyte Avenue towards the water you will pass the Planetarium & Vancouver Music Academy. As the road straightens there will be compounds along the right hand side. The False Creek site is the second compound. Check out the map below.



**Race Course:** will be determined on race day, based on conditions.

**Race Registration:** Fill out registration form (page 2) and fax or e-mail by Wednesday, March 3 2010. All other forms (waiver/CORA), can be submitted on race day.

**Race Fee:** \$60 per OC-6 team (\$10/paddler/race), \$30 for junior teams. Cash or checks, make checks payable to FCRCC. (CORA membership will be required). No extra charge for teams that request an experienced steersperson, though this must be made in advance.

**RELEASE OF LIABILITY AND INDEMNITY AGREEMENT BY SIGNING THIS RELEASE YOU WILL WAIVE CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE.**

**\*\*\*PLEASE READ CAREFULLY\*\*\***

To: False Creek Racing Canoe Club, all sponsors, joint venturers, directors, representatives, volunteers, officials, agents, and officers of false creek racing canoe club (collectively called the "host"):

I am aware of and understand that the sport of paddling has inherent dangers, hazards, and risks (collectively called "risks"). The following is only a partial list of these risks:

Negligence of the host; weather/water conditions; failure of equipment; collision between boats and other watercraft; negligence of the escort boat/driver

I understand that injuries resulting from such risks are a common and ordinary occurrence of the sport. I freely accept and fully assume all the risks and the possibility of personal injury, death, property damage or loss resulting from being a participant and/or member of the club.

I have read and understand the rules and this release, and i agree to abide by them. I acknowledge that it is my sole responsibility to act in such a manner as to be responsible for my own safety and participate within my own limits. I understand that these rules are solely for the purpose of regulating this club.

I, (together with my heirs, next-of-kin, executors, administrators, and assignees, collectively called "legal representatives") agree as follows:

1. To waive any and all claims that i may have against the host, the city of Vancouver, and the district of Vancouver.
2. To release the host from any and all liability for any loss, damage, injury, or expense that I or my legal representatives may suffer as a result of my participation due to any cause whatsoever, including negligence on the part of the host.
3. To hold harmless and indemnify the host from any and all liability for any property damage or personal injury to any third party resulting from my participation.
